REGULAR BOARD MEETING

B. PURCHASE OF PROPERTY AT 17027 SHILOH CHURCH ROAD

Motion B - moved by Mr. Carter

"The Board approves the purchase of the property at 17027 Shiloh Church Road, Georgetown, Delaware for the amount of \$199,000.00."

Mr. Watson explained that this is another one of the "piano key" properties that borders the Jones Crossroads Landfill. It is around 5 acres. The purchase price is \$199,000. It had been appraised and there is enough money in reserves for this property. It is staff's recommendation to purchase this property to increase the buffer from our neighbors. Mr. Griffiths asked if there would be any demolition on the property. Mr. Watson said that the house on the property would be demolished.

C. PURCHASE OF INDIVIDUAL INTEREST IN PROPERTY AT 562 MAHAN CORNER ROAD

Motion C - moved by Mr. Carter

"The Board approves the purchase of one-third undivided individual interest in 562 Mahan Corner Road, Marydel, Delaware for the amount of \$460,000.00."

Second – Mr. Griffiths

Mr. Watson said that this property was contiguous to the Sandtown Landfill. It is contiguous to the Thomas Farm and the Dixon Farm. It is important for DSWA to get access to this property in the long-term. It would be a potential future landfill area. DSWA has been interested in the property for many years. This is the first opportunity to get a piece of it. Staff highly recommends this chance to purchase the interest in the property. Mr. Esposito noted that this item was discussed in Executive Session during the May 25, 2023 Board meeting. Mr. Griffiths asked if there was any concern about the other two owners having control of the property. Mr. Parkowski explained that the land was no longer in a trust and

that the property was divided among the three sisters and there was no preclusion for any sister selling their interest.

Report of the Technical Affairs and Facilities Management Committee

D. PURCHASE AND SERVICE OF A NEW LANDFILL COMPACTOR AND SALE OF DSWA'S USED LANDFILL COMPACTOR FOR THE SOUTHERN SOLID WASTE MANAGEMENT CENTER - CONTRACT P-23-876-SS

Motion D - moved by Mr. Griffiths

"The Board awards a contract for Purchase and Service of a New Landfill Compactor and the sale of DSWA's Used Landfill Compactor to Carter Machinery for the total cost of \$1,369.940.00 which includes a four-year extended warranty."

Second – Mr. Paraskewich

Mr. Watson said that this new compactor will replace an old one in use at the Jones Crossroad Landfill. This purchase includes selling the old compactor also. The old compactor is beyond its 5-year warranty. Mr. Watson commended the staff in negotiations reducing the cost to \$1.3 million. Staff recommends replacing this old compactor. Mr. Munyan explained that the old compactor was past its guaranteed buyback program. Carter Machinery offered DSWA \$40,000 for the old compactor so it will be used as a trade-in for the new compactor. Mr. Esposito asked if they would use it for parts or resell it. Ms. Roddy said that there was a used equipment market that it would probably be put in.
